These measures are not a substitute for GAAP financial measures. Therefore, we provide a reconciliation of the non-GAAP measures to the comparable GAAP financial measures as follows:

- Operating earnings of \$1,632.2 million adjusted for net realized gains (losses) of \$4.9 million and other after-tax adjustments of \$524.5 million equals net income attributable to Principal Financial Group of \$2,151.8 million.
- Net income return on average equity including accumulated other comprehensive income of 18.2 percent adjusted for net unrealized capital (gains) losses of 1.3 percent, other after-tax adjustments of (4.6) percent, net realized capital (gains) losses of (0.1) percent, and net unrecognized post-retirement benefit obligation of (0.7) percent equals operating ROE of 14.3%.
