The following information is being provided to you, prompted by the liquidation of Principal Funds, Inc. – SystematEx Large Value Fund (“Fund”) effective May 01, 2019.

Dividends Received Deduction (“DRD”). For corporate shareholders, the percentage of ordinary income distributions (dividend income and short-term gains, if any) for the tax year that qualifies for DRD is 83.18%.

Qualified Dividend Income (“QDI”). Certain dividends paid by the Fund may be subject to a maximum tax rate of 20%. The percentage of ordinary income distributions (dividend income and short-term gains, if any) for the tax year that qualifies for QDI is 81.50%.

Long-Term Capital Gain Dividends. The Fund distributed long-term capital gain dividends during the tax year ended May 01, 2019. Unless otherwise designated, long-term capital gain dividends are subject to a maximum tax rate of 20-percent, 15-percent, or 0-percent, depending on the shareholder's taxable income. To the extent necessary to distribute such capital gains, the Fund may also utilize, and hereby designate, earnings and profits distributed to shareholders on redemptions of shares as part of the Dividends Paid Deduction.
